Rapport fra PDG Stig Asmussen, Council Representative Distrikt 2310

1. KORT OM COUNCIL ON RESOLUTIONS (COR)

The Council on Resolutions (COR) møtes på nettet hvert år for å stemme over foreslåtte «resolusjoner». Council on Resolutions er regulert i artikkel 8 i Bylaws of Rotary International. Resolusjoner er anmodninger til styret i Rotary International eller the Rotary Foundation, om å iverksette tiltak som ikke krever endring i Rotarys konstitusjonelle dokumenter. (The RI constitution and bylaws, and the standard Rotary club constitution). De resolusjoner som foreslås bør ha betydning for hele Rotary, - ikke for å løse lokale eller administrative spørsmål.

Forslag til resolusjoner kan fremmes av klubber, distrikter, eller av Rotary Internationals styre. Stemmegivning foretas av lovrådsrepresentantene i distriktene i en avgrenset tidsperiode. Lovrådsrepresentantene er valgt for en 3-årsperiode, og kan ikke delegere stemmegivning til noen andre. Stemmegivning skjer ved at representanten går inn på «sin» side og stemmer innenfor den tidsperiode COR varer. Dessverre er det ingen anledning til debatt, i motsetning til COL.

Når nye resolusjoner vedtas, vil disse bli vurdert av Styret i hhv. Rotary International og the Rotary Foundation.

Årets COR var fra 15.oktober til 15.november 2019.

Frist for å fremme forslag til COR 2020 er 30. juni 2020.

Fristen for å fremme lovforslag til COL 2022 er **31.desember 2020**.

Måten å fremsette forslag til Concil on Resolutions og Concil on Legislation er formbundet. Men ved å se på tidligere forslag, burde dette være greit. COL/COR representanten kan være behjelpelig med utforming.

2. VEDTATTE FORSLAG

Det ble i år fremmet 33 forslag for The Council on Resolutions (COR) 2019. Syv av disse ble vedtatt, hvorav fem var anbefalinger til styret i RI og to var anbefalinger til The Rotary Foundation Trustees.

Jeg nevner her kort 19R-05 som anbefaler at alle klubber etablerer en «strategikomite». Den andre jeg vil nevne er 19R-17 en anbefaling om å lege mer vekt på yrkestjeneste som en del av medlemsutvikling. Den siste anbefalingen 19R-15 oppfordrer til å utarbeide retningslinjer for Rotaract-klubbene.

Som jeg rapporterte fra COL 2019 ble det vedtatt at Rotaractklubbene nå går fra å være et program i Rotary, til å være selvstendige medlemmer i Rotary International – dvs. i praksis Rotary «ungdomsklubber». Med de endringer som nå skjer, gir dette Rotary en historisk mulighet til foryngelse og å bygge opp klubber for yngre voksne.

Den vedtatte lovendring som skjedde på COL, må ses på bakgrunn av Rotarys medlemsmasse og klubbenes alderssammensetning. De fleste klubber fungerer meget godt for den aldersgruppe som er representert, men gir ikke nødvendigvis et godt nok tilbud til yngre medlemmer. Forslaget må bl.a ses som et tiltak for å lette overgangen fra Rotaract til Rotary og å trekke til seg yngre medlemmer.

Forslaget til COR 2019 vil følges opp av styret. Men allerede på styremøtet i oktober tok styret i Rotary International viktige beslutninger om Rotaract og vårt fremtidige Rotary. Hør bare:


- alle Rotaractklubber kan nå etableres uten en sponsor
- en Rotaractklubb kan nå organiseres med en Rotaractklubb som sponsor

- den øvre aldersgrensen til Rotaract fjernes (men fortsatt beholde klubbene som klubber for unge voksne), slik vi i alle år har ønsket i Norge
- styret oppfordrer alle distrikter til å inkludere Rotaractere i alle distriktskomiteer
- styret vil komme tilbake spørsmålet om medlemskontingent for Rotaractklubbene til RI
- oppfordre fremtidige RI presidenter til å oppnevne Rotaractere som rådgivere til RI komiteeer
- se på mulighetene for å utvikle en mobil app slik at Rotary og Rotaract klubbadministrasjon og kommunikasjon kan bedres

Styret besluttet også en målsetting om

- å øke antallet Rotaractere med 100% innen 2022.
- øke antallet Rotaractere som går over til Rotary med 20% innen 2022
- øke antall Rotaractere til 1 million innen 2029.

Den interesserte leser får ha meg unnskyldt, men dette er spesielt gode nyheter for en som har gode minner fra tiden i Rotaract på 80-tallet. Da hadde vi 15 Rotaractklubber – de aller fleste i vårt område. Tilsvarende var det god aktivitet i våre naboland.

23 WHEREAS, RI surveys have revealed that clubs with strategic plans are more

- 6 WHEREAS, strategic plans are multi-year endeavors, whereas governors and
- 7 club presidents serve a term of only one year. For this reason, too little attention
- 8 is paid to mid- or long-term strategies and too few clubs develop their own
- 9 strategic plan, and

- 11 WHEREAS, it is recommended that clubs maintain a minimum of five core
- 12 committees: administration, membership, public relations, service projects, and
- 13 Rotary Foundation
- 14
- 15 IT IS RESOLVED by Rotary International that the Board of Directors of Rotary
- 16 International consider recommending that clubs also form a strategy committee.

PURPOSE AND EFFECT

- 17 Mid- to long-term strategies are of vital importance for clubs. By introducing a
- 18 specific strategy committee, clubs will also make far greater use of RI's strategic
- 19 planning documents. Furthermore, instruction in strategy from governors and
- assistant governors will be far easier and more beneficial for clubs.

- 21 If implemented, this resolution would have no substantial financial impact on RI.
- 22 Rotary developed the Club Leadership Plan to simplify the club structure and
- 23 offer clubs the option to add committees as needed.

To request the RI Board to consider recommending guidelines for Rotaract clubs

Proposer(s): District 2660, Japan

Endorsed by: District 2660 through a ballot-by-mail, 7 June 2019

- 1 WHEREAS, the 2019 Council on Legislation voted to admit Rotaract clubs into RI
- 2 membership, and
- 3

4 WHEREAS, each Rotaract club, with the support of its sponsor club, should aim to 5 become an organization worthy of RI membership

- 5 6
- 7 IT IS RESOLVED by Rotary International that the Board of Directors of Rotary
- 8 International consider recommending guidelines for Rotaract clubs, such as a
- 9 minimum number of members, service activities for enhancing Rotary's public
- 10 image, and fiscal best practices, as they are admitted to RI membership.

PURPOSE AND EFFECT

- 11 The 2019 Council on Legislation voted to admit Rotaract clubs into RI
- 12 membership. This decision is intended to elevate their status, to make Rotary an
- 13 innovative and receptive organization that is capable of adapting to current global
- 14 realities, as well as to promote cooperation between Rotarians and Rotaractors in
- achieving a common goal of improving the world, their communities, and
- 16 themselves through the strength of their individual contributions.
- 17
- 18 However, many Rotaract clubs are currently under their sponsor clubs'
- 19 protection and therefore incapable of supporting themselves.
- 20
- 21 With these guidelines, both Rotaract and sponsor clubs will be able to organize
- 22 and engage in activities that are better aligned with Rotary's vision statement.

- 23 If implemented, this resolution would have no substantial financial impact on RI.
- 24 There are several resources already available that outline the guidelines for
- 25 Rotaract clubs, including the Rotaract Handbook, the Standard Rotaract Club
- 26 Constitution, the Recommended Rotaract Club Bylaws, as well as the Rotaract
- 27 informational page on My Rotary, <u>Rotaract Clubs: Guide for Our Members</u>.

To request the RI Board to consider publicizing all of Rotary's achievements and activities, including vocational service

Proposer(s): District 2580, Japan **Endorsed by:** District 2580 through a ballot-by-mail, 15 May 2019

WHEREAS, the Object of Rotary is to encourage and foster the ideal of service as a 1 2 basis of worthy enterprise and, in particular, to encourage and foster, among others, the application of the ideal of service in each Rotarian's personal, business, and 3 community life, or, in other words, in all aspects of a Rotarian's daily life, and 4 5 6 WHEREAS, the application of the ideal of service in each Rotarian's personal and 7 community life is called by such names as community service and youth service; 8 and the application of the ideal of service in each Rotarian's business life is called, among other things, vocational service, and 9 10 WHEREAS, currently, organized club, district, or RI community service activities 11 are emphasized as a means of developing membership or enhancing Rotary's public 12 image; however, those activities are only a part of the application of the ideal of 13 service by Rotarians. They are intended only as exercises, to provide Rotary club 14 members with training in service, and 15 16 WHEREAS, as expressed in the phrase "Enter to learn, Go forth to serve," Rotarians 17 18 should apply the ideal of service that they have learned in their meetings and service activities to their private and professional lives as well, and 19 20 21 WHEREAS, vocational service, in particular, is applied to what constitutes a large part of many Rotarians' lives - their professional activities. Vocational service 22 23 provides sustainable, wide-ranging service to communities every day. This is a major achievement by Rotary. 24 25 IT IS RESOLVED by Rotary International that the Board of Directors of Rotary 26 International consider publicizing all of Rotary's achievements and beneficial 27 activities, including vocational service, as it communicates them to the world. 28

- 29 Thoroughly publicizing the achievements of Rotary, as reflected in its many
- 30 beneficial activities will help to encourage and foster the ideal of service and is,
- 31 therefore, directly related to the Object of Rotary. It would also have a positive
- 32 impact on our membership development by advancing the wider recognition of
- 33 Rotary's significance.

- If implemented, this resolution would have no substantial financial impact on RI. 1
- 2
- Vocational service remains one of the foundational pillars of Rotary's programmatic activity, which includes different ways of publicizing Rotary's 3
- achievements. 4

To request the RI Board to consider emphasizing vocational service for the purpose of membership development

Proposer(s): District 2580, Japan **Endorsed by:** District 2580 through a ballot-by-mail, 15 May 2019

- 1 WHEREAS, in our ongoing efforts at membership development, we often encounter potential Rotary club members who turn down our invitations with remarks such 2 as, "Rotary activities are wonderful, but I don't have time for them." Such reasons 3 are often cited by younger professionals whose daily lives are devoted in large part 4 to their career development. However, this group is critical to Rotary if its 5 6 membership is to ever develop beyond its current levels, and 7 8 WHEREAS, to enhance Rotary's public image, our strategic plan in recent years has 9 emphasized such things as service activities and opportunities for participation in global group service activities that Rotary membership brings, and 10 11 WHEREAS, the Object of Rotary is to encourage and foster the ideal of service as 12 a basis of worthy enterprise and, in particular, to encourage and foster, among 13 others, the application of the ideal of service in each Rotarian's personal, 14 business, and community life, or, in other words, in all aspects of a Rotarian's 15 16 daily life, and 17 18 WHEREAS, organized service activities are generally the application of the ideal of service in each Rotarian's personal and community life. In contrast, vocational 19 20 service is the application of the ideal of service in each Rotarian's business life. Unique to Rotary, vocational service is a useful concept, providing sustainable and 21 22 wide-ranging service activities. It makes the application of the ideal of service possible for many whose jobs occupy a large proportion of their lives, as well as for 23 younger professionals. Furthermore, the fact that vocational service may, in fact, 24 contribute to one's own professional success is effective in membership 25 development, especially as it relates to this younger demographic 26 27 28 IT IS RESOLVED by Rotary International that the Board of Directors of Rotary International consider emphasizing Rotary's unique and useful concept of 29 vocational service for the purpose of membership development, particularly as it 30
- 31 relates to the recruitment of younger adults.

PURPOSE AND EFFECT

- 1 Vocational service enables Rotarians to serve their communities through their
- 2 useful occupations. Developing membership by emphasizing vocational service
- 3 mainly to the large majority of the working adult population will help to advance
- 4 the Object of Rotary.
- 5
- It should be noted regarding those members who do not have an occupation orhave retired that a "vocation" is not simply an occupation or a profession. Rather,
- 8 it is a commitment to one's own work in serving their community. Many of those
- 9 who have retired from their occupations or professions are nevertheless actively
- 10 engaged in their own goals, i.e., a vocation.
- 11
- 12 It should also be noted that the Object of Rotary calls for members to apply the
- ideal of service in all aspects of their daily lives. As long as this is done, the
- 14 Object is attained.
- . 15
- 16 Vocational service is unique to Rotary and is effective in recruiting our most
- 17 desirable membership demographic –young adults, many of whom are actively
- 18 employed. This is a very compelling reason to use it as part of our membership
- 19 development efforts.

- 20 If implemented, this resolution would have no substantial financial impact on RI.
- 21 Vocational service remains one of the foundational pillars of Rotary's
- 22 programmatic activity and currently includes several programs to recruit younger
- 23 members to Rotary.

To request the RI Board to consider informing Rotarians about the progress of RI's tax status change

Proposer(s): District 2660, Japan **Endorsed by:** District 2660 through a ballot-by-mail, 7 June 2019

- 1 WHEREAS, the 2019 Council on Legislation adopted the RI Board's Position
- 2 Statement 19-117, authorizing the Board to take appropriate action to convert RI
- 3 into a tax-exempt organization under section 501(c)(3) of the United States
- 4 Internal Revenue Code, and
- 5
- 6 WHEREAS, the Board had cited, among the proposal's other benefits, an annual
- 7 cost savings of six to seven hundred thousand dollars, and the position statement
- 8 was adopted with the understanding that such a change might divide Rotarians in
- 9 the United States who are dubious about the benefits of such a tax status change
- 10
- 11 IT IS RESOLVED by Rotary International that the Board of Directors of Rotary
- 12 International consider informing Rotarians about the progress of RI's tax status
- 13 change; presenting their projection on any changes to the five-year financial
- 14 forecast as reported to the Council on Legislation, as well as their spending plan
- 15 for the resulting surplus, once it is realized; and submitting the plan to the
- 16 Council on Resolutions.

- 17 Authorizing the tax status change of RI to a section 501(c)(3) of the United States
- 18 Internal Revenue Code was an important decision that will not only bring
- financial benefits to RI, but will also promote activities based on the RI StrategicPlan.
- 21
- 22 The debate as to whether Rotary is a voluntary organization whose purpose is
- 23 fellowship or a charitable organization that makes positive changes through
- volunteer activities, ended with the latter winning out. Given that, the surplus
- 25 resulting from the tax status change must be spent in ways that are acceptable to
- 26 Rotarians around the world.
- 27
- 28 For that reason, it is desirable for the RI Board to not only publicize the progress
- of the change in tax status, but also carefully consider how to spend the resulting
- 30 surplus in meaningful ways and, finally, to submit the Board's decisions to the
- 31 Council on Resolutions.

1 If implemented, this resolution would have no substantial financial impact on RI.

To request the Trustees to consider allowing modifications to the original approved budget of a global grant

Proposer(s): District 3141, India

Endorsed by: District 3141 through a ballot-by-mail, 27 May-27 June 2019

- WHEREAS, global grant projects are submitted by clubs and districts and approved
 online through the Foundation's online Grant Center, and
- 3
- WHEREAS, global grant reporting is done online by the host and sponsor clubs and districts, and
- 6
- 7 WHEREAS, sometimes it is necessary to change the budget structure of a grant
- 8 after it has been approved, usually due to modifications in the original components9 of the project, and
- 10
- WHEREAS, all grant reporting is done on the basis of the original approved budgetas the modified budget is not reflected online, and
- 13
- WHEREAS, this can lead to misunderstandings in the financial reporting of thegrant
- 16
- 17 IT IS RESOLVED by Rotary International that the Board of Directors of Rotary
- 18 International consider requesting the Trustees of The Rotary Foundation to
- 19 consider allowing modifications to the original approved budget of a global grant
- 20 project if such modifications have been approved by a regional grant officer or The
- 21 Rotary Foundation Trustees.

(End of Text)

- 22 The purpose of this resolution is to ensure smooth, online financial reporting of
- 23 expenses that have been approved by The Rotary Foundation. At present, these
- changes can be entered only as additional budget items. Also, line items which
- have been modified on the project budget are not currently reflected in the online
- ²⁶ report. This leads to an inaccurate perception that grant monies have been or are
- being spent on unapproved line items, or are at variance with those reported onthe budget. This, in turn, may cause confusion over the process of online
- reporting, and can lead to assumptions that funds have been misused.

- 1 The modification suggested here will allow grant officers to reopen a locked
- 2 global grant project and replace its original budget with a modified one, thus
- 3 facilitating the grant reporting process for clubs and districts.

- 4 If implemented, this resolution would have no substantial financial impact on RI.
- 5 Allowing modifications to the original approved budget of a global grant would
- 6 require changes to the Grant Center and could be accomplished through the use
- 7 of existing resources.

To request the Trustees to consider making global grant funding available for local electricity supply projects

- 12 The modern world cannot function without electricity. Our lighting, information,
- 13 and air conditioning/heating systems, as well as our manufacturing,
- 14 transportation, and other industries are all reliant upon this one essential
- 15 resource.

- 17 Access to water, health, and education in rural areas of developing countries can
- 18 be improved with an affordable and sustainable supply of electricity. This would
- allow for pumping and sterilization of water, safe storage of vaccines and
- 20 medicine, distance learning, etc. This would also contribute to the well-being of
- 21 the local populations and, therefore, encourage them to stay in their
- 22 communities.

- 24 Electricity should be made available without a heavy infrastructure, in an
- 25 affordable and sustainable manner. It's production and storage, while
- challenging, will contribute to the overall movement towards sustainable
- 27 development, resulting in an efficient, reliable power source with a minimal

- 1 If implemented, this resolution would result in an increase in expenses for The
- 2 Rotary Foundation.

- 4 Currently, sponsors may include electrification as part of a global grant, provided
- 5 it supports the activities the grant addresses in the area of focus. For example, if
- 6 the grant seeks to outfit an operating theater and a reliable electrical supply is
- 7 required, the grant may include solar panels.
- 7 8
- 9 An additional area of focus would be required in order to have electrification as a
- 10 stand-alone project type. Annual administrative expenses to support an
- additional area of focus are estimated at US\$300,000, which includes the
- 12 modification of the existing grant application software.

- 14 Although we are focusing on grant processing impact, there are additional
- 15 administrative impacts in other business areas, such as finance.
